Minutes of the Meeting Held on Wednesday 10th February 2021

In Attendance: Cllr Marsh, Cllr DeVeaux, Cllr Green, Cllr S Pashley, Cllr J Pashley and Cllr Vickers.

22/2021 Apologies: None received.

23/2021 Declarations of interest: Cllr Pashley: Item 34/2021 (b): Parkway Maintenance.

24/2021 Fifteen-minute public discussion period: Two members of the public attended the meeting to report issues with anti-social behaviour on Brinsworth Road. Council members advised the residents to report the incidents to the Police via 101 and invited them to attend the Neighbourhood Watch meeting on the 12th of February.

25/2021 To approve the minutes of the meeting held on Wednesday 13th January 2021: The minutes were approved and signed as a true record. Proposed by Cllr DeVeaux and seconded by Cllr Vickers.

26/2021 Matters arising from the minutes: None.

27/2021 Borough Councillors Report: None in attendance.

28/2021 To Discuss Matters Relating to the Parish and to Assign Ownership:

- a) Cllr DeVeaux reported an issue with the lighting levels around Sheffield Lane: Clerk to contact RMBC.
- b) Cllr Vickers reported an issue with youths meeting up in the village and breaking lockdown rules: Cllr DeVeaux to highlight the problem at the Neighbourhood Watch meeting.

29/2021 To Discuss Open Matters Relating to the Parish:

- a) Overhanging branch on River Rother: Ongoing.

30/2021 Meetings: Cllr DeVeaux advised that he had attended a Kiln project meeting, the illumination should be displayed in April. Cllr's J & S Pashley advised that they had attended a meeting with RMBC to discuss the drainage in the Brinsworth Road area. Enquiries need to be made with Yorkshire Water to question the purpose of the tankers at the pumping station near New Street.

31/2021 Flood Committee: Meeting held on 1st February 2021. The Clerk advised that meetings had been requested with RMBC and The Environment Agency but to date no responses had been received. A drainage engineer from Barratt Homes had agreed to meet virtually with the committee to discuss the concerns raised by residents on the Blue Mans Way estate.

32/2021 Council vacancies: No updates received. There are three Councillor vacancies.

33/2021 Neighbourhood Watch Scheme: Cllr DeVeaux advised that a meeting had been scheduled for Friday 12th February via Facebook at 6.30pm.

34/2021 Highways and Footpaths:

- a) **Reduction of New Brinsworth Road speed limit:** No updates received.
- b) **Sheffield Lane traffic issues:** Cllr DeVeaux advised that RMBC had accepted the petition.
- c) **A630 Parkway maintenance:** Cllr S Pashley advised that the work had started. Cllr DeVeaux reported complaints from residents regarding the overnight works.
- d) **Installation of CCTV:** Council approved for the CCTV to be installed on St Mary's Drive/Church Lane.
- e) **Catcliffe Blitz Day:** Cllr S Pashley advised that the project will go ahead on the 18th of February.
- f) **Fly tipping:** Council noted the recent incident on Station Road that had been cleaned up by RMBC.

- a) **Maintenance and repairs: Entrance to Poplar Way play area:** Council resolved for the Clerk to contact DMBC to request a cost to lay matting in the area.
- b) **Poplar Way fencing:** Council requested the Clerk to obtain quotes to replace the missing fencing.
- c) **Ownership of land at Highfield View:** No updates.

- a) **Health and safety and maintenance issues:** The Clerk advised that the project had been delayed due to an issue with sourcing a crash bar handle.
